## II. About CAUC



In today's rapidly and disruptively changing air transport environment (e.g., the impact of COVID-19 and climate change), the aviation personnel require access to advanced and comprehensive knowledge of operation, safety and risk management, economics and finance, and environmental protection, to promote the sustainable development of the global aviation industry through improving the operational efficiency and safety of the whole air transport system.

The two-year master program, responding to the main goals of No Country Left Behind (NCLB) initiative, is designed for students with a university degree and relevant experience in the air transport industry. It covers a wide area of expertise related to air transport, while enabling students to enhance the professional knowledge in relevant disciplines and gain competitive advantages in the aviation industry. With systematic learning, students will gain the skills required for a successful career in various sectors of the air transport industry, including airlines, airport companies and authorities, civil aviation departments and air transport consultancies.

The program includes 14 modules of 1 to 2 weeks each, and tutored visits to airports and airlines with experts from the industry in the 1st or 2nd semester, as well as a professional thesis module in the 3rd and 4th semesters.

### 3rd & 4th Semester

Students are required to carry out a professional thesis under the supervision of a CAUC professor and an industry tutor, either on campus or abroad, based on a topic related to the fields of Airport Management, Aviation Safety and Security, Aviation Operation or Business Management, etc., depending on students' personal expertise and interests.

### III. Qualifications of Applicants

1. Applicants should be non-Chinese citizens and in good health, and will observe the Chinese laws and the regulations of Civil Aviation University of China.
2. Applicants for Master programs should be under the age of 40.
3. Applicants for Master programs should have a Bachelor degree or the equivalent educational background of a Bachelor degree and relevant experience in the air transport industry.
4. Applicants should have the qualified ability of listening, speaking, reading and writing in English.
5. Applicants should have no criminal record.

3. Foreigner Physical Examination Form;
4. Personal Information Form;

6. English Proficiency Proof (Except for English Native Speakers);
7. Study Plan (in English);
8. Police Clearance Record (If it's not written in English, a notarized English translated version is needed);
9. Two Recommendation Letters from Professors or Associate Professors (in English);
10. Self-Introduction Video (in English).

## V. Scholarship

### 1. Freshmen Scholarship

CAUC is authorized to provide Tianjin Municipal Government Scholarship, and the university also offers CAUC Freshmen Scholarship to eligible freshmen. The Freshmen Scholarship application should be submitted together with students' enrollment application.

## 2. Outstanding Enrolled Students Scholarship

CAUC provides CAUC Outstanding Enrolled Students Scholarship for all eligible enrolled international students every year since their second academic year. The Outstanding Enrolled Students Scholarship application should be submitted right after the new semester starts since the second academic year.
